**Invitation for Bids for procurement of Fabricated Steel Parts
for Trail Bridges**

1. The Government of Nepal (GoN) has allocated TB-SWAp funds to Bhumlu Rural Municipality for **Trail Bridge Program** and the Rural Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
2. The Bhumlu Rural Municipality invites Electronic Bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted in www.nepaltrailbridges.org.np may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
4. Eligible Bidders may obtain further information at the office of Bhumlu Rural Municipality and inspect the bidding documents in www.bolpatra.gov.np
5. Bidding documents may be purchased from www.bolpatra.gov.np/egp by eligible Bidders, on submission of payment of a non-refundable fee for bid documents as mentioned in the following table, until the **2076/9/21 (2020/1/06)** the first date of publication of this notice.
6. Bids must be submitted through www.bolpatra.gov.np/egp, on or before **(2076/09/21) at 12 noon** Documents received after this deadline shall not be accepted.
7. Bids will be opened in the presence of Bidders' representatives who choose to attend at Bhumlu Rural Municipality on **2076/09/21 at 1 PM** at the office of Bhumlu Rural Municipality, Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amount to a **minimum of 2.5 % of the quoted Bid amount (inclusive of VAT)**, which shall be **valid for 30 days** beyond the bid validity period.
8. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No. **0560000841 Bhumlu Rural Municipality Salle-bhumlu kavre Nepal Bangladesh Bank Bhumlu Branch** and submit bank deposit voucher along with the bid.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
10. Pre-Bid Meeting shall be held at the office of Bhumlu Rural Municipality on 2076/09/14 12 noon (Dec -30 2019).
